John serves on a team mandated to analyze fraud with the goal of developing underwriting tools and procedures to prevent fraud altogether. Because of his easy-going nature and strong public speaking skills, John is a sought-after speaker for FCT-hosted seminars. He is a member of the Canadian Association of Accredited Mortgage Professionals (CAAMP) Mortgage Fraud Prevention Subcommittee. John was called to the Ontario Bar in 1993 after attending McGill and Queen’s Universities.
